Overall Comment: "GravityZone is good enough that I wouldn't discourage others from using it. My use of GravityZone is primarily as a tool for patching Windows servers on a monthly basis. It's significantly better than running updates manually, but the process is very much happening in a void. There is very little insight into where each server is in the update process. There are also significant and unpredictable delays. I might tell 10 servers to reboot, some will reboot immediately, others may take a long while just to initiate the reboot."


